# ARCHITECTURAL GUIDELINES AND APPLICATION FORM REVISIONS

In July 2022, the HOA Board approved changes to the Architectural Review Committee (ARC) guidelines removing the requirement for ARC approval for a small number of specific projects. The "pre-approved" projects that fall strictly into the "pre-approved categories" no longer require an ARC review. # What are the pre-approved categories?

- Repainting house/shed/walls/gates in the same color of paint and Color scheme that has already been approved by the ARC.
- Repainting the house/shed/walls/gates in a pre-approved color scheme: Sherwin Williams "Sunset Acres II HOA" and Dunn Edwards "Sunset Acres II HOA". Extend painting to visible portions of the concrete slab.
- ❖ Any and all plantings in the back yard (fenced area only).
- Non-permitted (i.e., does not require a Marana building permit) changes/additions to the backyard (inside the fence) that stand less than six-feet in height from ground level. (must be both non-permitted and stand less than 6-feet in height inside the fence for exemption).
- Metal security doors matching the pre-approved color schemes.
- Solar energy devices as defined by ARS 44-1761 mounted on *existing* structures. ARS 44-1761 defines the solar energy devices as solar panels for generating power to your house/pool, it does not mean lighting or accessories that use small solar panels to power themselves.
- Antennas/satellite dishes with the largest dimension of one-meter or less and in compliance with all Federal exemptions.
